Weigh in will begin at 1:30 PM You get one chance to weigh your biggest fish for the big fish prize. You must be a paid member of the MSCST to enter any events. You may not possess more than 15 legal fish a DNR 3 man limit max. You will be allowed to weigh 5 legal fish 5 points for Lake Trout 10 points for Salmon 15 points for Steelhead 20 points for Brown Trout plus weight. Fin clipped fish get 5 bonus points each. The Port Championship will use a 100 point per event descending score system. Highest total 5 events score will be Port Champion.
